

**Job Title:** Foundation Operator / Driller  
**Reports to:** Assigned Supervisor

### **POSTION OBJECTIVE**

Foundation Operator/Driller will be tasked with leading crews in the construction of deep foundations. The driller will be performing large diameter drilling, earth retention and shoring. The driller will be working with the project managers to make sure each project is completed on time and properly. Drillers will also be responsible for some onsite repair and maintenance.

### **ESSENTIAL DUTES AND RESPONSIBILITIES**

- Daily Time Cards for the full crew
- Job notes
- Proficient in safely loading and lashing down loads for transportation.
- Unloading equipment and tools.
- Perform pre-trip inspection and make minor mechanical adjustments as necessary on equipment.
- Fill out and turn in reports on equipment condition when returned from a job.
- Operating hydraulic track drills.
- Operates tools and equipment to perform support tasks for drilling operations.
- Provides manual labor as needed specific to the task.
- Coordinate with Project Managers on project needs.
- Works harmoniously with peers, supervisors, and the public and complies with Inland's policies.
- Willingness to travel in the Northwest region
- Flexibility to come in early and/or stay late to meet the demanding schedule of a service based company.

- Understand the nature of foundation drilling.
- Proper use and understanding of crane rigging and signaling.
- Drill tools and equipment.

- NCCCO Crane certification is preferred but not required; in house training and certification may be available.

### **WORK ENVIRONMENT:**

- This job will be predominately outside work.
- This job will often include out of town work

**Physical Demands, Hazards, and Working Conditions:** The employee will have to meet these requirements, with or without reasonable accommodation, to succeed in this position.

The position requires very heavy work involving exerting over 75 pounds of force on a regular basis. While performing the duties of this job, the position is exposed to outside work conditions which could mean extreme heat and/or cold, wet/humid conditions, bright and/or dim light, dust or pollen. While performing the job duties the employee may also be exposed to intense noise levels, vibration, fumes or noxious odors, moving mechanical parts, working around heavy equipment, and heights.
